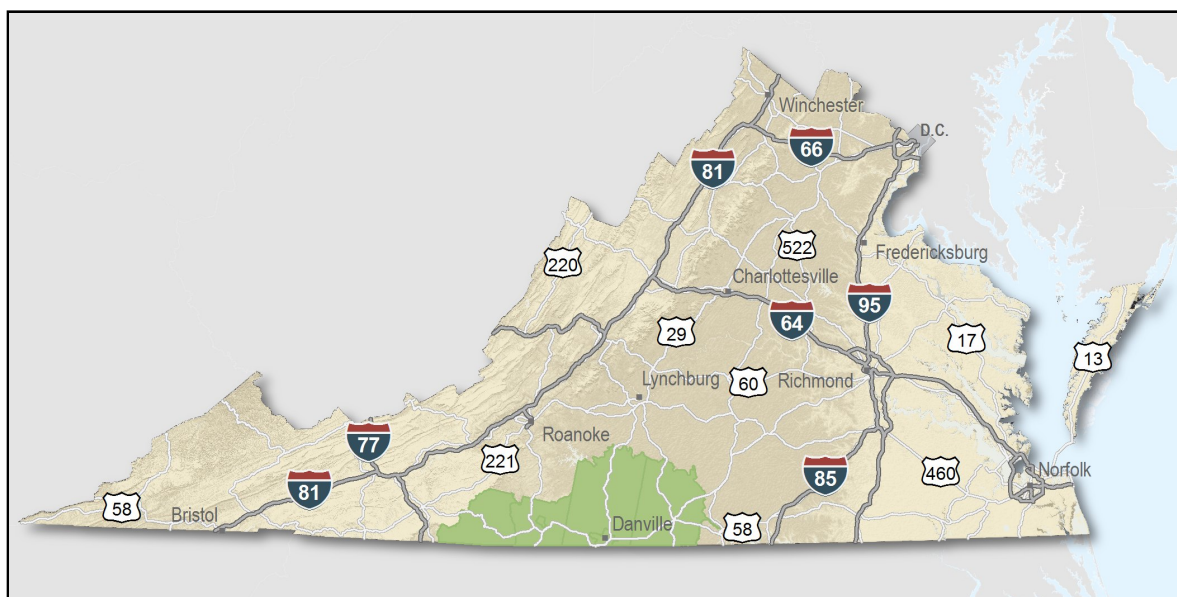

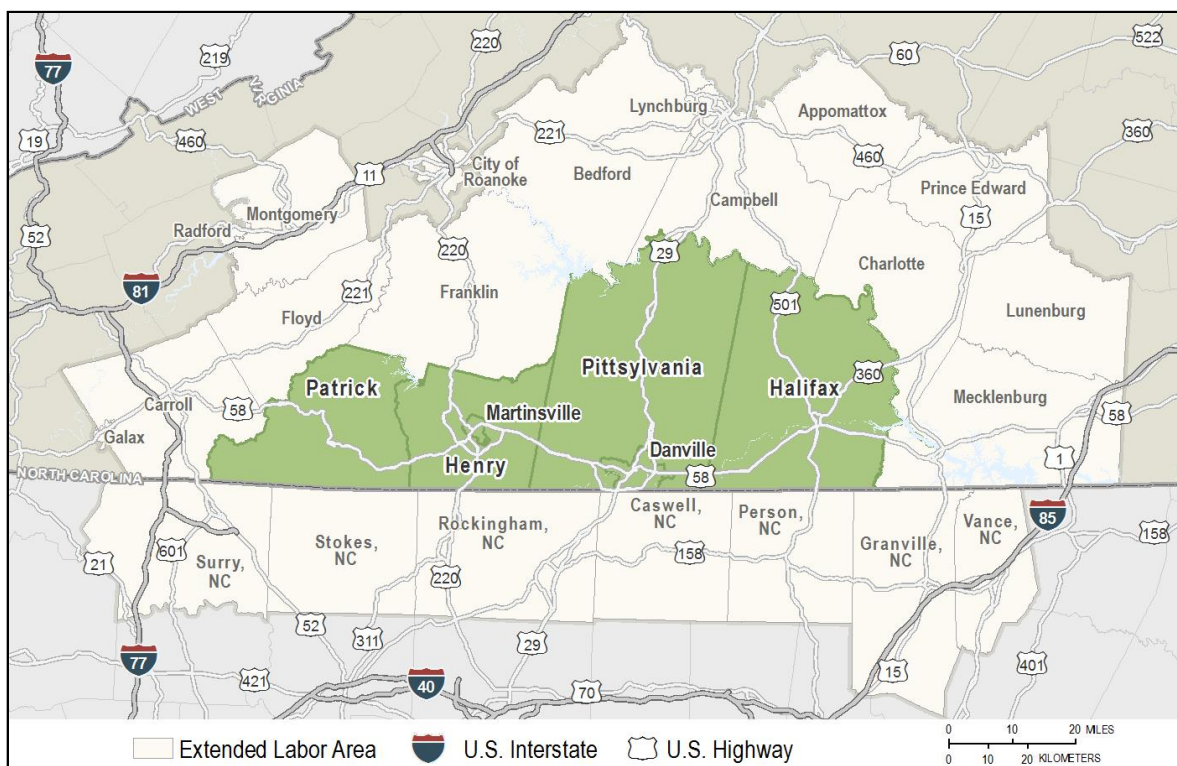


Location

Southern Virginia, located along the Virginia/North Carolina State line, encompasses 2,706 square miles. The region is dominated by a strong manufacturing sector that comprises companies in the food processing, plastics and wood products sectors. Other significant economic activity results from the back office, distribution and agricultural sectors. High-quality four-lane divided highways and rail transportation systems service the area providing convenient access to markets on the East Coast.

An excellent highway system coupled with easy access to interstates make the region extremely well-suited to reach mid-Atlantic markets and international shipping facilities.

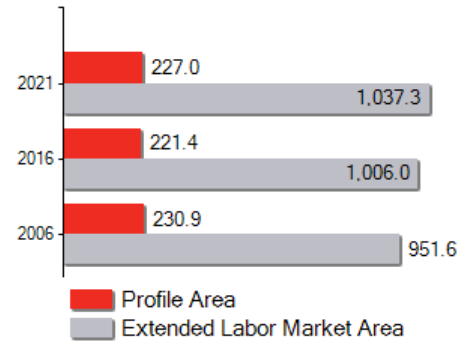

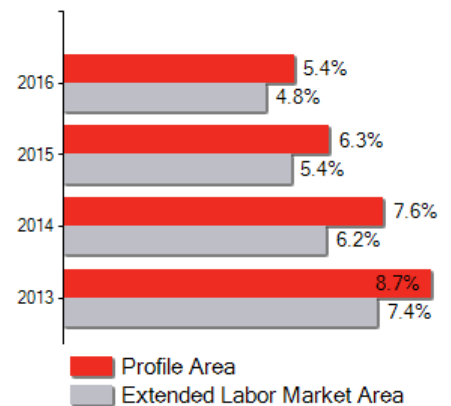

Government and Taxes

Government

Southern Virginia includes the counties of Halifax, Henry, Patrick, and Pittsylvania, along with the cities of Danville and Martinsville.

Each locality has a comprehensive plan and a zoning and subdivision ordinance.

Each county has a board of supervisors and a county administrator. The cities have a city council and city manager.

There are ten incorporated towns in Southern Virginia.

Taxes

Localities in Virginia collect a 1% sales tax. They do not tax other items taxed at the State level.

Counties and cities in Virginia are separate taxing entities. Therefore, a company pays taxes to either a county or to a city.

If a company is located in a town, it pays town and county taxes except for utility taxes which are paid only to the town and the license tax which is paid only to the town unless town law permits the additional collection of a county tax.

Manufacturers pay real estate, machinery and tools, truck and automobile, utility, and sales taxes.

Nonmanufacturers pay real estate, tangible personal property, truck and automobile, utility, and sales taxes. They also may pay either a merchants' capital or a license tax.

Virginia's tax rates are historically low. Localities collect a 1 percent sales tax. They do not tax other items taxed at the State level. Counties and cities in Virginia are separate taxing entities. Therefore, a company pays taxes to either a county or to a city.

Community Facilities

Southern Virginia is served by four hospitals with a total of 730 beds. The Danville Regional Medical Center is a 290-bed major regional medical center offering comprehensive treatment including 24-hour emergency care, a maternity unit, and a substance abuse program. The hospital is affiliated with Virginia Commonwealth University's Medical Center and Duke University's School of Medicine. Memorial Hospital of Martinsville and Henry County, servicing the western part of the region, is a 223-bed comprehensive medical-surgical facility. Halifax Regional Hospital with 192 beds is an affiliate of the Halifax Regional Health System. Halifax Regional provides acute and long-term care, dementia care, behavioral health and outpatient services, home health and hospice care to the region. Pioneer Community Hospital of Patrick County is a 50-bed facility, providing general, urological, cataract, and pediatric surgery, as well as acute and intensive medical care.

Southern Virginia is served by more than 500 physicians and 125 dentists representing numerous medical and surgical specialties.

Nursing and extended care are available to area citizens through 15 nursing homes located throughout the region with a total of 2,004 beds.

Southern Virginia boasts a high level of support and involvement in the arts. The cities of Danville and Martinsville are the leaders in cultural activity. The Museum of Fine Arts and History in Danville is an affiliate of the Virginia Museum and houses art galleries, studio space and an auditorium used for area musical and dramatic productions.

More than 900 places of worship are located in the region representing most major Protestant denominations, Catholic and Jewish faiths.

Four public library systems and ten branches are located throughout the region with a collection of more than 625,000 volumes. Additional library resources are available to the public at Averett College, Danville Community College, and Patrick Henry Community College.

Danville offers several major shopping centers and Piedmont Mall, a regional shopping mall. Martinsville commerce is centered in Liberty Fair Mall and the renovated central business district. Numerous goods and services are available in the Central Business District in and around the Town of South Boston in Halifax County. Factory outlet stores are prevalent throughout the region. Residents utilize a variety of stores located in the towns throughout the region.

Virginia is the northernmost right-to-work state on the East Coast.

Lifestyle

Southern Virginia boasts a high level of support and involvement in the arts. The Museum of Fine Arts and History in Danville is an affiliate of the Virginia Museum and houses art galleries, studio space, and an auditorium used for area musical and dramatic productions. Professional music, dance, and dramatic performances are also offered through the Halifax County Fine Arts Series. Local residents also participate in the dramatic, comedy and musical productions of the Halifax County Little Theatre. The Prizery, located in Halifax County includes a Welcome Center, performing arts theatre, art gallery, classrooms, and space for community functions. The Danville Science Center, housed in the renovated, historic Danville train station, is the first satellite of the Science Museum of Virginia. Danville Community College's Educational Foundation Museum of Natural History houses a unique collection of African and Asian animals, an extensive collection of native birds, and exhibits of fossils, wildflowers, fish, and Native American relics. In Martinsville, the Piedmont Arts Association sponsors many workshops, displays, and special events each year including showings by local, regional, and national artists and craftsmen. Stage productions by TheaterWorks, Piedmont Playmakers, the Martinsville Community Chorus, and the Martinsville Opera Society provide outlets for amateur talent. The Virginia Museum of Natural History, a Smithsonian affiliated museum is also located in the city of Martinsville. Averett College is a major cultural resource for the region as a regular series of concerts and drama is presented, along with guest appearances by nationally known performers. A Planetarium and Science Museum in Pittsylvania County presents numerous special programs free of charge to the public.

Southern Virginia hosts several traditional annual festivals and events that draw top name bands and large crowds of music lovers.

Area residents have numerous recreational activities available to them. VIRginia International Raceway in Halifax County is one of the world's finest road courses. VIR hosts pro and club car and motorcycle races, racing and riding schools, and other services and events. South Boston Motor Speedway, a NASCAR sanctioned race track has been host of Busch Series Grand National Racing since 1982. It is recognized as the world's fastest short track and home to Winston Cup drivers Ward and Jeff Burton. The Martinsville Speedway hosts four major NASCAR sponsored auto races attracting in excess of 100,000 spectators annually.

Four major lakes are located in Southern Virginia providing a large variety of water-related activities including swimming, wind surfing, water-skiing, boating, fishing and sailing. Fairystone State Park in Patrick County offers a 150-acre lake with picnic facilities, beaches, boating, swimming, fishing, camping, and horseback riding. Philpott Lake, also in Patrick County, offers a 110-mile shoreline, boating docks, camping, swimming, and fishing. Smith Mountain Lake and Leesville Lake are located in northeastern Pittsylvania County. These unique scenic lakes provide a vast amount of water-related recreation. Smith Mountain Lake, with its 500-mile shoreline, is also the site of a 1,200-acre state park. Patrick County is a gateway to the Blue Ridge Parkway where hiking, picnicking, camping, fishing, and hunting opportunities abound. Mabry Mill, located on the Blue Ridge Parkway, is a unique facility that highlights the cultural heritage of the southwestern Appalachian Mountains and mountain industries.

Other recreational opportunities are available to tourists and residents. Eleven public golf courses and seven private courses are located throughout Southern Virginia. In addition to providing golf courses, these facilities often also provide swimming pools and tennis courts. For game hunters, three game preserves, operated by the Virginia Commission of Game and Inland Fisheries, are located in the region.

Professional auto racing comes to nearby Virginia International Raceway, South Boston Speedway, and Martinsville Speedway numerous times each year, attracting the best in both professional and amateur auto racing. Located within a short drive are NASCAR venues such as Lowe's Motor Speedway (Charlotte, NC) and Richmond International Raceway (Richmond, VA).

Professional baseball is available in Southern Virginia. Danville is home to the Danville Braves, an affiliate of the National League Atlanta Braves. Martinsville is home to the Coastal Plain League's Martinsville Mustangs. The counties also sponsor local organized sports teams for adults and youth.

Southern Virginia hosts several traditional annual festivals. Danville sponsors the four-day Harvest Jubilee, featuring live entertainment, crafts, and activities for all ages. During the summer, Wayside Park in Patrick County hosts two musical events. The Annual Beach Music Festival is held in June and the Annual Bluegrass Festival is held during the 4th of July weekend. Each event draws top name bands and large crowds of music lovers. The annual Cantaloupe Festival held in July in Halifax County has become a major celebration attracting thousands from throughout Virginia and North Carolina. The Halifax County Fair is held in October, attracting an average annual 35,000 attendees.
